The 411 on SOX 404

Most people have heard about Sarbanes-Oxley. The Act was driven by large corporate scandals in the United States (Enron, Worldcom, etc.), circa 2000.

Legislation was created to address accounting deficiencies and hold key employees criminally and civilly accountable for the financial reports of their company. Controls and Audits are the primary means of implementation of the Act.

It Adds Up to More than Just Accounting

If SOX concerns financial reforms, what does that have to do with Information Technology? In effect, *SOX is the forced implementation of Best Practices* (which you already follow anyway, right?).

The beauty here is that nothing is really new. It's just a matter of identifying the key pieces of the Internal Controls puzzle and then assembling them in a way that satisfies auditing expectations.
